RELEASE, WAIVER AND INDEMNITY AGREEMENT

RELEASOR is an adult individual or is the parent or guardian legally liable for a minor child who wishes to participate in the *FIGURE 8 RACES* event sponsored by the Park County Fair, the SPONSOR.

In consideration of being permitted to participate on a team in the *FIGURE 8 RACES* event activities, RELEASOR, his parents, his legal representatives, heirs and assigns, hereby releases, waives and discharges SPONSOR, its officers, employees, and workers, from all liability to the RELEASOR, his parents, his legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting there from or on account of any injury to participants person or property, even injury resulting in death of the participant whether caused by the negligence of the SPONSOR or otherwise while RELEASOR is participating in the *FIGURE 8 RACES* event activities.

RELEASOR agrees to indemnify the SPONOR from any loss, liability, damage or cost they may incur due to the presence of individual participant or minor participant in or upon the areas where the *FIGURE 8 RACES* activities will take place, whether caused by the negligence of the SPONSOR or otherwise.

RELEASOR hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of SPONSOR or otherwise while in or upon the areas where the *FIGURE 8 RACES* activities will take place and while participating in the *FIGURE 8 RACES* activities.

RELEASOR expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Wyoming and that if any portion thereof is held invalid, it is agreed that the balance shall; notwithstanding, continue in full force and effect. RELEASOR expressly understands that the *FIGURE 8 RACES* activities involve and inherent risk of injury to oneself and to others. SPONSOR is not liable for any injuries to those who participate in the *FIGURE 8 RACES* activities.

FIGURE 8 RACES ARE FOR FUN

ENTRY AND PRIZES:

1. The entry fee is \$30 per entry. Entries will be accepted on a first come, first entered basis. The entry deadline is Monday, July 11, 2011 or until filled. No entry will be considered accepted until driver and all pit crew members have submitted required release forms along with entry form.
2. Car numbers will be confirmed by pre-registration only, on a first come, first entered basis. Duplication of numbers will not be permitted. Letters and symbols will not be accepted.
3. Races will consist of seven (7) heats, limited to a maximum of ten (10) cars each with two (2) Main Heats, should sufficient number of entries be received. All vehicles will run in a Main Heat. There will not be a loser's heat.
4. The top three (3) qualifiers in each heat will receive cash awards. The Finale will have a \$1,000 purse and a trophy will be awarded to the Grand Champion.

DRIVERS, PIT CREW AND PIT AREA:

1. All DRIVERS and PIT CREW members **MUST** be at least 16 years old and **MUST** submit a release BEFORE entering the PIT AREA. All DRIVERS and PIT CREW members under the age of 18 **MUST** provide parental consent.
2. **ABSOLUTELY NO ALCOHOLIC BEVERAGES PERMITTED IN THE PIT AREA.** Any driver or pit crew member found in possession of alcohol while on the Park County Fair Grounds, at any time during the event day, **WILL IMMEDIATELY DISQUALIFY THE ASSOCIATED CAR AND DRIVER FROM THE EVENT.** Anyone in possession of a PIT PASS entering the Beer Garden will not be permitted to enter the PIT AREA.
3. Access to the PIT AREA is restricted to event organizers/workers, DRIVERS and PIT CREW. PIT PASSES will be issued to the DRIVER and three (3) PIT CREW members for each entry that are in compliance with all entry rules. No additional passes will be issued or sold.
4. Any unauthorized person found in the PIT AREA will be escorted off the Fair Grounds. ANY UNAUTHORIZED PERSON FOUND WORKING ON A VEHICLE WILL AUTOMATICALLY DISQUALIFY THE ASSOCIATED CAR AND DRIVER.
5. Only the Figure 8 Car, one support vehicle and one trailer will be allowed in the PIT AREA per registered and complete entry. An unloading ramp is not available. Be sure to make the necessary arrangements to load and unload your Figure 8 Car.
6. Figure 8 Cars may be in the PIT AREA NO EARLIER THAN NOON and NO LATER THAN 3 P.M. on the day of the event. **No late entries will be permitted.**
7. Figure 8 Cars must be removed from the Park County Fair Grounds by 11:59 P.M. on the night of the event. Any vehicle not removed will be disposed of at the owner's expense. The Park County Fair will not be held liable for any damages or liability relating to the vehicle.

COMPETITION REGULATIONS:

1. ALL DRIVERS **MUST** ATTEND THE DRIVER'S MEETING HELD 30 MINUTES PRIOR TO THE EVENT.
2. DRIVERS **MUST** wear helmet and goggles or a face shield to protect eyes from flying debris.
3. No passengers will be allowed to ride in the Figure 8 car at any time during the competition.
4. NO car deemed unsafe shall be permitted to enter the arena.
5. DRIVER or other registered PIT CREW member **MUST** remain with the car in the PIT AREA until it has passed inspection, forms are verified signed and a flag has been issued. Once the car has been inspected it will be assigned to a heat.
6. Unsportsmanlike conduct is grounds for DISQUALIFICATION of the associated car, driver and pit crew for the current and FUTURE years.
7. NO INTENTIONAL HITTING OF THE DRIVER'S SIDE DOOR WILL BE PERMITTED! CAR AND DRIVER WILL BE DISQUALIFIED.
8. Drivers **MUST** remain alert to signals given by the Field Judges.

Black Flag	=	Disqualification
Red Flag	=	Emergency Stop (ALL drivers <u>MUST</u> stop until signaled to continue)
Green Flag	=	Go
Yellow Flag	=	Slow Down / No Position Changes
9. Drivers will not be allowed to leave their cars UNLESS the car is turned over, on fire, or the driver is instructed to do so by event officials.
10. There will be a 20 minute repair break after the first 7 heats, or when designated by event officials. Cars MAY NOT be worked on until this time. Working on a car before this time will result in DISQUALIFICATION of the car and driver.
11. Absolutely NO switching cars for the Final Heat! Driver **MUST** compete with the same car he/she qualified in.
12. The winner is determined by the first car to cross the finish line after a predetermined number of laps. Thereafter, cars must remain in a forward motion EXCEPT if a bottleneck occurs at a corner. Reverse will be allowed to clear the corner only. Deliberate contact while in reverse will result in car and driver DISQUALIFICATION.
13. CAR AND DRIVER MAY BE DISQUALIFIED FOR: leaking gas, hung-up on a beam, reckless driving, leaving the Figure 8 pattern, sitting dead on the course, fire, and intentionally leaving the Figure 8 pattern so as to intentionally hit another car.
14. Drivers will complete ten (10) laps in the first seven (7) races. Drivers will complete fifteen (15) laps in the Winner's Heat (Finale).
15. Event organizers, the Park County Fair and/or its delegates reserve the right to make any necessary changes in the rules and regulations. Every effort will be made to give as much advanced notice as possible.

AUTOMOBILE SET-UP PROCEDURES:

1. Any small front or rear wheel drive, 4-cylinder vehicle or V-6 front wheel drive mini-van with 120 inch wheel base is acceptable. No AWD vehicles will be permitted. Front and rear wheel drive vehicles will compete in same heats. Due to size of cars and size of arena track, maximum wheelbase allowed is 104 inches. No turbo engines allowed. NO PICK-UPS OR 4X4's.
2. The ONLY WELDING ALLOWED ON THE BODY SHEET METAL WILL BE THE DRIVER'S DOOR. Three or four point Roll Cage is acceptable without reinforcing the body of the car. ANY WELDING ANYWHERE ELSE WILL RESULT IN IMMEDIATE DISQUALIFICATION of the car and driver.
3. Car must be stock – no "strippers".
4. All chrome, fiberglass, die cast metals (i.e. head-, tail-, and parking light assemblies) and ALL glass **MUST** be removed from the inside of doors, passenger compartment and/or trunk prior to entrance onto the Park County Fair Grounds. NO ADDED WEIGHTS!
5. Driver's door must be securely fastened at all times.
6. Car **MUST** HAVE A LAP AND SHOULDER BELT. Cars must contain original functioning seat belt. Seat and seat belts shall be attached securely to the floor. ****NOTE**** Seat belt grab or slack-adjusting ratchet **MUST** be removed or secured/blocked to prevent over tensioning of belt upon impact ALL AIRBAGS **MUST** BE DISCONNECTED OR REMOVED.
7. Bumpers **MUST** be original. NO push bumpers. NO trailer hitches.
8. All cars **MUST** have numbers at least 10" high, placed on each side of the car, on top and the deck lid. Sponsors may be painted on the car. No risqué or obscene language permitted.
9. Air pressure in tires must be factory recommended air pressure. All four tires must be the same size. No farm or mudder type tires.
10. No anti-freeze or additives – water only.
11. Driver's window net is **mandatory**.
12. No holes are to be cut in roof – factory sunroofs only.
13. Driver's door **MUST** be florescent orange or green and the rest of the car must be a different color.
